





## Contracts Signed for New Quraiyat, Wattaya Police Stations



Two contracts were signed on 30 / 1 / 2014 by His Excellency Lt. General Hassan bin Muhsin Al-Shuraiqi, Inspector General of Police and Customs with two competent companies for the construction of new buildings for the Quraiyat and the Wattaya police stations in Muscat Governorate.



Both the projects have been initiated within the Royal Oman Police march of improving the services for the public in line with the increasing population and physical development.

A number of senior police officers attended the signing ceremony.

# The Charge of the Light Brigade


